## ACADEMIC QUALIFICATION FOR TEACHING POST

- a. The Ph.D. degree of the candidate has been awarded in a regular mode;
- b. The Ph.D. thesis has been evaluated by at least two external examiners;
- c. An open Ph.D. viva voce of the candidate has been conducted;
- d. The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e. The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC or similar agency.
  - Note: The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.
- (iv) Preference would be given to candidates having teaching experience or commensurate experience in National Law Schools/Reputed Law Colleges/University/Reputed Law Firms/Industry or equivalent.
