General Instructions

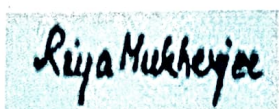

 - Net Banking / UPI [A/C No: 86152010033935, IFSC: CNRB0018615, Canara Bank, SKP Branch]

Candidates shall be required to show a screenshot of the payment confirmation page at the time of admission.
